**ORDER**

No. A.60011/1/2020-D&SJ(L)/A Dated 24<sup>th</sup> March, 2020: As per the directions issued by the Hon'ble Gauhati High Court in Notification No. 18 dated 24<sup>th</sup> March, 2020 vide Memo No. HC.III-06/2020/819-844/G dated 24.3.2020 and Notification No. 19 dated 24<sup>th</sup> March, 2020 vide Memo No. HC.III-06/2020/845-855/G dated 24.3.2020, the functioning of the District Court, Lunglei Judicial District, shall remain restricted with effect from 25.3.2020 till 4.4.2020 and only cases of extreme urgency involving liberty will be taken up. The hearing of such cases, including remand matters related to fresh arrest and extension of remand, shall be taken up by the following Judicial Officers:

1. H. Laldusanga, Chief Judicial Magistrate
2. Ms. Julie Lalhlupuii, Judicial Magistrate First Class

Matters which are already fixed for listing and hearing upto 4.4.2020 shall stand deferred unless extreme urgency is shown for the immediate hearing of the matter. The following ministerial staff are nominated as Nodal Officers for the filing and listing of cases for hearing in their respective districts:

2. Ms. Linda H. Lalrinawmi (9366408411), BC-III, Lawngtlai

Ministerial staff who are not required to report for duty on any given day shall not leave the station headquarters without prior permission. They shall make themselves available for duty on call and they shall be deemed to be on duty during the entire period from 25.3.2020 till 4.4.2020.


